

Therefore we have to arrange permanent shelter home to shift our residents, we have started our efforts and trying to contact our well wishers and donors to get their support for fund for their support.


Our long term vision is to develop our own care home building with latest amenities, we have started our efforts to reach that destination

At present, we have 10 inmates. Now we want to increase another 30 mentally ill adults. We have also registered under The Right of Persons with

Disabilities Act, vide 916/19 dt. 28/11/2019 with the Social Defence Dept. Govt. Of Gujarat; Therefore we are initiating a new project for slum children with special needs (Divyang) to expend our service to provide medical and support services in the city of Vadodara that expansion of services will be addition in nos. of beneficiaries in the year 2020 onwards.



We are looking for the Land /building to accommodate our inmates on permanent basis. As Vadodara city is an industrial town so the cost of land / building is very expensive.






We have got 12 AA and 80 G certification from the Income Tax Department, GOI. All the donations for our cause may be send eighter by cheque or online bank transfer.
